### President's Perspective

At the last meeting there were three new sections introduced for submission to the club bylaws. The first section falls under Article III and was written to define a Guest pilot and the rules associated with a Guest flying at the club field. The last line of this section is designed for perhaps someone visiting from out-of-town for a week and therefore may be able to fly more than three times. This section was designed to encourage non-members to join the Propbusters rather than have them take advantage of the unwritten Guest rule.

The next two sections fall under Article II and were written to clarify issues with training and certifying new pilots. Again, the Bylaws fall short in this area.

We can also look at all three of these new sections as yet another step forward in operating our field in a safe manner. I think that a lot of us get caught up in the fun and enjoyment of this hobby that we forget that, in the hands of an untrained or inexperienced pilot, these model aircraft can be quite dangerous and cause a lot of damage. Therefore, it is up to all of us, as a club, to create the safest environment in which to fly in, whether it is through club rules, bylaws or just common sense.

So the decision to add these new sections to the Bylaws will be left up to the members at the next meeting, either 'as is' or with changes. If you have any ideas for improvement, come to the March meeting and voice your opinion. Just in writing this article, I've already come up with some changes that I will propose at the meeting.

## February Meeting

Meeting started at 6:04 pm with 12 members present. Gary brought up an error in last month's newsletter. Gary/Doug made a motion to accept the amended secretary's report. Doug/Al voted to accept the treasurer's report and pay bills.

Guests flying at the field. We discussed some proposed Bylaw changes to stop non-members from flying at the field for an extended period of time without joining the club. Proposed Bylaws amendments will be put in the next newsletter.

Gary Wilkerson is also an AMA Intro Pilot. A host member can only fly 1 time on host member's equipment. Guests than have to join AMA and Propbusters to continue flying at our field.

New Members. Guy Bratt and his grandson Billy Griffith were voted into the club.

New Business. Josh O. has volunteered to be a pilot trainer. He would also like to be one of our AMA Intro pilots as Jack is already one, so being it for more than one club is not cost effective.

Bulk Fuel order will go in April 1st. 3 different brands. The order form will go out in next month's newsletter.

Motion passed to end the meeting 7:47 pm.

## Proposed Propbusters Bylaws

### Article II

**Section IV:** Any pilot flying solo at Propbusters field must be certified "Pilot" status by the club President or his designee.

### Article II

**Section V:** Club membership must be applied for, and proof of valid AMA membership is required before a student can begin training. Training of Non-members at Propbusters field is not permitted. The instructor is responsible for verification of students AMA document and club status. Student pilots may fly only on "buddy box" until granted pilot status by the club president or his designee.

### Article III

**Section IX:** AMA member guest pilots are welcome up to three times per year per guest (excluding contest or special events). Guest must be accompanied by a host Propbusters member, and agree to follow all club rules and By-laws. Host members are responsible for the actions of their guest. Guests using the field more than three visits are expected to join the club. Host members allowing a guest to use the field more than three times may themselves be held responsible for guest dues and fees. This may be waved in advance by a ¾ vote of the executive board on a case-by-case basis.

## Treasurer's 2004 Report

I will spare the details of the month-by-month financial summary; those details are available in the monthly newsletters. Last year we took in \$2,920.05, 44% was from membership dues, 56% from monetary donations and fundraisers. We spent 119% of that income to run and improve our field and club (a 19% deficit): 36% of our expenditures were spent on field improvements, 19% for repair and maintenance parts for the tractors, 10% was spent on gas for mowing the field, 9% on supplies and mailing the newsletter, 11% for prizes, hall, supplies food etc., 9% for club hats for resale, 3% for AMA, 3% for septic. These numbers do not include the numerous member donations of supplies, equipment use, and materials used for field improvements, and of course the hundreds of man-hours of time donated by our members.

This coming year we are also faced with having to pay rent to the park for our field. Major expenditures also will include repair to both tractors and field equipment.

The Propbusters club has always strived to keep membership dues as low as possible, while maintaining one of the best fields in the area. Our club, like any other Non-profit organizations must rely heavily on the support of our members. Our dues structure only provides a portion of the capital needed to operate our club. To survive, we need the continued support of volunteers to work our fundraisers and events to generate operating capital. To help keep cost at a minimum we also need the continued support of members to freely donate their time and resources for the maintenance of the field and field equipment. The support needed from members includes mileage and gas for personal vehicles, personal labor, use of personal tools and equipment. The club has always, and will continue to pay out of pocket expenses such as: Gas for club or professional equipment used at the field for maintenance or improvement, supplies, service parts and repair parts for club equipment. We run an above board operation, we must require an itemized receipt from place of purchase for all reimbursable expenditures, and this is just a good commonsense business practice. Any expenditure also requires approval by the body at a regular meeting or board approval as appropriate.

Not every member is able to donate their time, due to many personal or professional reasons. Every person experiences different times in their lives when they have more or less time they are able to donate. Our club does not require service from our members, we just ask everyone to pitch in when they can. The next time you are at the field, look around and give a thought to all the hard work by all the members to get it where it is today, and maintain it for the future.
